Subject: Notice for Implementation of Repurpose Used Cooking Oil (RUCO) Initiative- Reg.

Reference: 1. File No. RCD-18/1/2021-Regulatory-FSSAI-Part (1) dated 20/01/2022.

2. Minutes of Meeting held through hybrid mode (physical & online) on 6th July, 2022 to discuss the Status and Handling of Used Cooking Oil (UCO) in Eastern and North Eastern Region.

Sir/ Madam,

As you are aware of the detrimental health effects of using used cooking oil which has undergone changes due to repeated frying, it is essential to monitor the quality of cooking oil during frying.

2. As per the Hygienic and Sanitary condition stated in Part V of Schedule 4 of the Food Safety and Standards (Licensing and Registration of Food Businesses) Regulations, 2011, as amended in 2017, vegetable oil having developed Total Polar Compound (TPC) more than 25% shall not be used. FSSAI vide directions no. RCD-18/1/2021-Regulatory-FSSAI dated 20.01.2022 mandated Food Business Operators (FBOs) whose consumption of edible oil for frying is more than 50 litres per day to maintain the usage and disposal record.

3. FBOs shall dispose Used Cooking Oil (UCO) to agencies authorized by FSSAI from time to time, and maintain traceability thereof.

4. In view of the above, as per directions promulgated vide order cited above, you are directed to furnish the record of usage of oil, UCO generated and means of disposal of UCO as per format attached in "Annexure I" for last 3 months within 15 days of the date of this notice.
